## Dear Sirs,

On behalf of the Director, ICAR- CIAE, Bhopal, I am to invite your lowest quotation for "providing paver blocks and ramp for existing vehicle parking shed (staff and visitors) — size: 60ft. ×22ft. at ICAR- CIAE, RS Coimbatore" from the civil contractors as per enclosed Annexure-I on following terms & conditions.

- 1. The rates should be submitted on the prescribed schedule of work and notified in the Annexure-I and the contractor should sign it. Taxes, if any, must be quoted, separately otherwise, it will be assumed that the rates are inclusive of all taxes, etc.
- 2. No over writing in the offer is permitted. However, correction if any must be signed by the contractor.
- 3. Quotation must be sent in a sealed cover envelope mentioning "Quotation for providing paver blocks and ramp for existing vehicle parking shed (staff and visitors) size: 60ft. ×22ft. at ICAR- CIAE, RS Coimbatore".
- 4. Quotations must be sent through Registered Post/Post/Speed Post/Couriers to the Head(I/c) ICAR-Central Institute of Agricultural Engineering, Regional Station, Veerakeralam Road, Sugarcane Breeding Institute Post, Coimbatore-641 007 due on 18.09.2024 05.00 PM.
- 5. No quotation will be accepted by hand.
- 6. Director, ICAR-CIAE, Bhopal has every right to extend the date of submitting the quotation.
- **7.** Any quotation received after the date of submission mentioned in the notice of inviting quotation shall be rejected and returned unopened to the quote/contractor.
- 8. The contractor shall be entirely responsible for the security and safety of persons, employed by him.
- 9. During the work, the contractor shall be responsible for any loss caused by its worker and shall be recovered from the bill.
- 10. The payment will be made within reasonable time say 30 days after completion of work. No part payment will be made to the contractor. Since the mode of payment will be e-payment system, hence bank account No. and name of the Bank with location and IFSC code No. of Bank may be mentioned in the quotation positively.
- 11. The Director, ICAR-CIAE, has the right to cancel awarded work if the contractor fails to perform jobs specified in the work order.

- 12. If the contractor does not care to improve its performance in a reasonable time in spite of written/verbal instruction and warning. The decision of the Director, ICAR-CIAE shall be final.
- 13. If any interpretation of rules/provision arises, the decision of the Director, ICAR-CIAE is final and shall be bound to accept by the contractor.
- 14. Director, ICAR-CIAE reserves every right to accept or reject the quotation without any reasons thereof.
- 15. The work should be carried out as per specification as per Annexure-I
- 16. All dispute subject to Bhopal Jurisdiction only.
- 17. All communications must be addressed to the undersigned by Designation only and not by name.
- 18. All the tools required for completion of work will be arranged by the contractor.
- 19. TDS will be deducted as per rules.
- 20. Loss and/ or damages: In case of any loss or damage done to the property of the Institute and Krishiyantra Colony by the personnel provided to the Institute by the Contractor for labour service contract for civil work at this Institute, the full damages will be recovered from the contractor.
- 21. The labour contractor agrees to discharges their entire legal as well as other obligation in respect of their employees in respect of their wages and other service conditions and shall also comply with all the rules and regulations and provision of law in force that may be applicable to them from time to time. Statutory obligations under contract labour (Regulation and Abolition Act), 1970, Workmen's Compensation Act, EPF and MP Act, Industrial Dispute Act etc. The Labour contractor agrees to indemnify and keep indemnified the Institute from any claims, loss or damages that may be caused to the institute on account of the labour contractor failure to comply with their obligations under the various law towards their staff/employees by them for any loss or damage to the institute due to acts/ omissions of the contractor.
- 22. The contractor shall be responsible to give the minimum wages to the laborers as per the Govt. rate as amended from time to time including all other fringe benefits as per labour laws of Govt. of India. It is amply and mutually agreed that the institute shall not be responsible for any welfare measures benefits etc to the laborers and that the institute shall not be responsible for any untoward incident/casually of the laborers during their engagement in the activities work.
- 23. Institute will not responsible for unloading, handling, storing, staking of the material at site.
